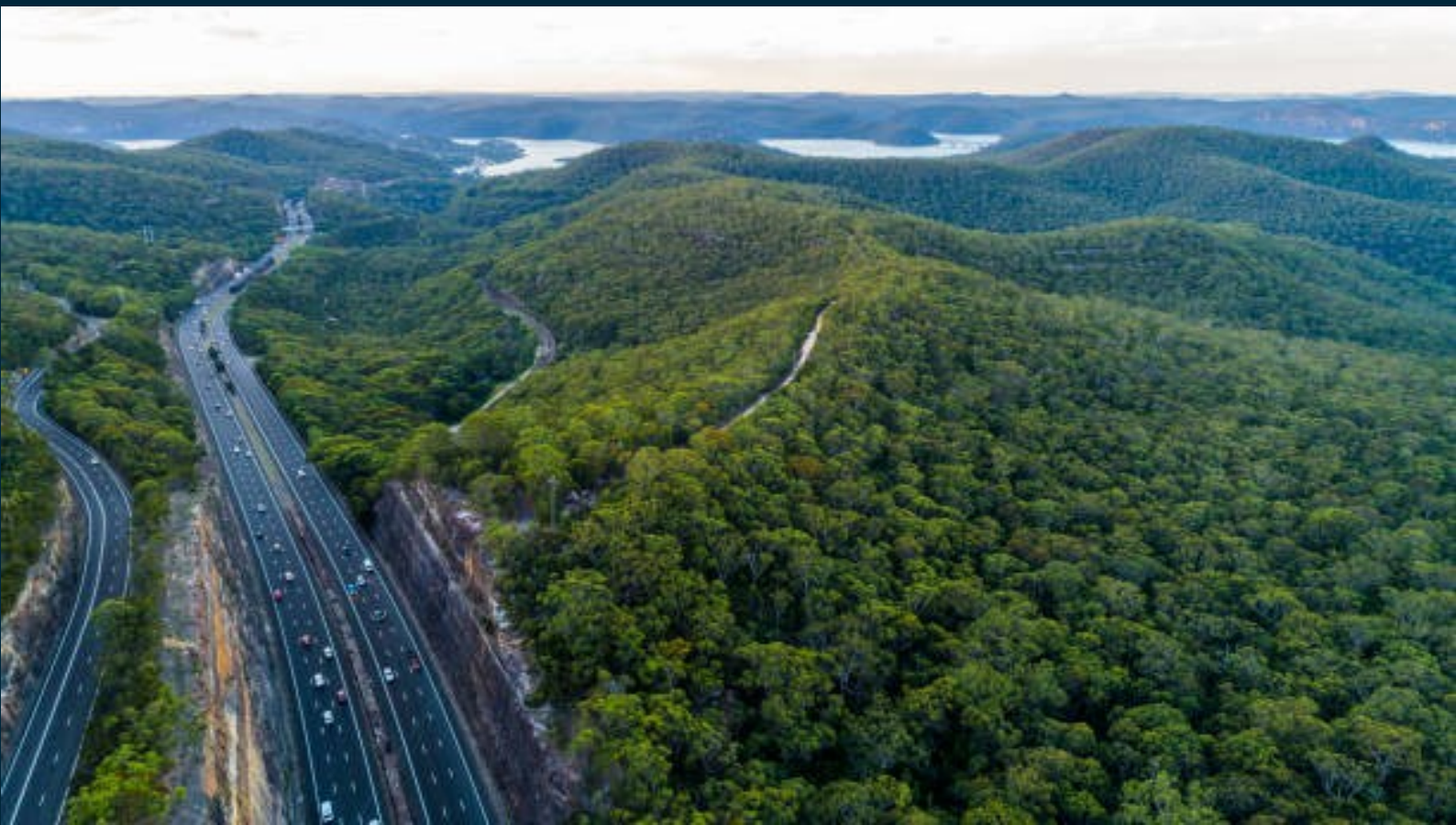




Carbon Reduction Plan



Introduction

Since 2015 TCH Leasing has achieved ISO 14001 certification, to aid a commitment to minimise impacts on the environment, as a result of our business activities. TCH Leasing has been fully engaged in promoting environmental sustainability internally, as well as helping our customers achieve their environmental aims. This carbon reduction plan further commits TCH Leasing to reducing our carbon emissions to Net Zero by 2050.



Commitment to Net Zero

TCH Leasing is committed to achieving Net Zero emissions by 2050. This Carbon Reduction Plan conforms to PPN 06/21.



Baseline Emissions Footprint

Baseline emissions are a record of the greenhouse gases that have been produced in the past. Baseline emissions are the reference point against which emissions reduction can be measured.



Baseline Data

Baseline Year: 2021

Additional Details relating to the Baseline Emissions calculations.

TCH Leasing established a baseline measurement across Scope 1, 2, and subset of Scope 3. 2021 was the most recent full year of carbon emissions data that we modelled and is therefore used as our baseline.

The activities that account for Scope 1 and 2 emissions include the use of energy for heating, fuel for company vehicles, and electricity consumption. The base year emissions cover 100% of scope 1 & 2 emissions.

TCH Leasing have calculated a subset of Scope 3 emissions, that is required for the Carbon Reduction Plan. These are upstream transportation and distribution, waste generated in operations, business travel, commuting and downstream transportation and distribution.
